# Presidents Letter

Last month I editorialized about clinics--a great way to get concentrated training on a specific topic of equestrian interest. This month I have another equestrian experience to share--I recently went on vacation to Vermont for the Sugarbush Tolt Trek. I spent 5 days "tolting" across the Vermont countryside on Icelandic horses from the Vermont Icelandic Horse Farm. Each day started with a hearty breakfast at a delightful country inn.

We spent the next 3 to 5 hours following trails and country roads through the Sugarbush Mountains and the Mad River Valley, followed by an awesome 3-course dinner. The food was as amazing as the scenery!

Prior to this trip, the only experience I had on a gaited horse was the 5 minutes I spent on Marilyn Colvin's TWH last March. I was excited to try the 5 natural gaits of the Icelandic horse: walk, trot, and a really smooth canter, plus a racking gait known as the "tolt." The fifth gate is a side-to-side pace, which in a traditionally trained Icelandic can become the "flying pace." The name is accurate: those little horses can truly fly!

I had an absolute ball on this trip, spending my days with a nice herd of horses and six other people, randomly drawn together by a common interest in horseback riding. We enjoyed one another so much, as a matter of fact, that we're already planning another equine vacation next year. I would give the same advice for an equine vacation that I did for a clinic--ask questions and know what you're getting into.

The ride I was on was rated "novice," but I was a bit concerned for one of my fellow riders the first time we broke into a canter. Know your limits and know your tour. Five hours a day in the saddle is a lot!

In case you're wondering what on earth this trailriding story is doing in the driving club news, I will now explain. Equitours, the group through which I booked my tolt trek, has recently introduced a Carriage Driving tour in Aiken, SC. Should you so desire, you can spend a week learning or perfecting the fine art of carriage driving. Instruction includes putting-to and driving a team, practice with cones, trails and obstacle skills, and dressage. According to the brochure, (I'll be happy to share mine), the program is flexible and can be adjusted to your needs. Lodging is at a historic hotel or B&B in Aiken.

There are lots of companies in addition to Equitours that offer equestrian vacations, and I've even seen one or two others that offer carriage driving. My advice would be to let your fingers do the walking, on the internet, to find an equestrian trip that suits your needs. I certainly plan to take another, after the great time I had "tolt trekking" in Vermont.

The undersigned participant, and his or her parent or legal guardian if under the age of 18 years, does/do hereby execute this release waiver, and indemnification for himself/themselves and his or her/their heirs, successors, representatives and assigns and, thereby agree(s) and represents as follows:

To release Whips and Wheels Driving Club, it's members, agents and representatives affiliated with this activity from any liability, loss, damage, costs, claims and/or causes of action, including but not limited to all bodily injuries and property damage arising out of participation in the activity, it being specifically understood that said activity includes the handling of equine by the undersigned participant. The undersigned person(s) further agree(s) to indemnify Whips and Wheels Driving Club, it's members, agents and representatives affiliated with this project, and hold them harmless for any loss, damage, cost, claim judgment, or settlement which may be brought or entered against them as a result of the undersigned person's participation in said activity.

If involved in equine activities pursuant to NC Chapter 99E of NC General Statutes, the undersigned(s) executes(s) this waiver of the undersigned(s) right to sue and agree(s) to assume all risks resulting from the "intrinsic dangers of equine activities". "Intrinsic dangers of equine activities" is defined as those dangers or conditions that are an integral part of equine activities, including but not limited to: (i) the propensity of equines to behave in ways that may result in injury, harm, or death to persons on or around them; (ii) the unpredictability of an equine's reaction to such things as sounds, sudden movement, and unfamiliar objects, persons or other animals; (iii) certain hazards such as surface and subsurface conditions; (iv) collisions with other animals or objects; and (vi) the potential of a participant acting in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or not acting within the participant's ability.

This waiver shall remain valid unless expressly revoked by the participant or Parent or guardian of a minor. The revocation shall be in writing, which shall be addressed to the provider and shall become effective thirty (30) days after delivery to the provider. The undersigned(s) should maintain all medical and health insurance to cover all risks of any kind in any place in livestock, equine, and/or other activities.

I the undersigned participant will ensure equipment is in good condition at all times, wear and use all safety equipment. Minors (under the age of 18) MUST wear helmets and be accompanied by an experienced driver when in the carts/carriages.

<u>WARNING:</u> Under North Carolina law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities. Chapter 99E of the North Carolina general statutes.
