## FROM THE PONY PADDOCK

So in typical senile fashion I was sitting at home working on this newsletter when I get a call from work: "aren't you going to come relieve me tonight?" Totally and completely forgot!...un-lady-like words issued from my mouth....so.....l am now finishing the letter from work! May have to take a break if a sick person needs me....

I am going to be lazy this month and pull some items from the internet and am going to attempt to make sense of the FHV-1 virus.

### Update on Equine Herpesvirus

The guarantine on J&H Stable has been lifted. No further horse either at the stable or that left the stable in the last two months has fallen ill. As you may recall, four horses were euthanized and one recovered due to the neurologic form of Equine Herpesvirus(HSV-1).

### What is EHM?

Equine herpesvirus myeloencephalopathy (EHM) is another name for the neurologic disease associated with equine herpesvirus (EHV) infections. Neurological signs appear as a result of damage to blood vessels in the brain and spinal cord associated with EHV infection. Interference with the blood supply leads to tissue damage and a subsequent loss in normal function of areas in the brain and spinal cord. Horses with neurological disease caused by EHV-1 infection (or any neurological virus) can soon become uncoordinated and weak and have trouble standing. Difficulty urinating and defecating may also occur. Often the rear limbs are more severely affected than the front. Incubation period of EHV-1 is 2-8 days; EHM can start as late as 8-12 days after that or may appear without the EHV-1 symptoms having ever been noted.

What is with all the numbers attached to the equine herpesviruses?

To date, nine EHVs have been identified worldwide. Three of these—EHV-1, EHV-3, and EHV-4—pose the most serious health risks for horses.

### EHV-1:

Can cause four manifestations of disease in horses, including a neurological form, respiratory disease, abortion, and neonatal death. EHM is most often due to mutant or neuropathogenic strains of EHV-1, so called because of a particular mutation in the genome.

### EHV-3:

Causes a venereal disease called equine coital exanthema that affects the external genitalia.

EHV-4:

Causes a nonfatal upper respiratory tract disease in foals and is uncommonly associated with abortion and rarely with neurologic disease.

How common are the herpesviruses? BY TWO YEARS OF AGE ALMOST ALL HORSES ARE INFECTED WITH EHV-1. The initial exposure generally occurs in foals from contact with their dams. The virus can then become latent, or inactive, setting up a carrier state that is life-long. Carrier horses show no symptoms, but the virus can reactivate during times of stress, becoming highly contagious again.

### Vaccination and transmission

EHV-1 and EHV-4 are both known as "rhino" for rhinopneumonitis and are vaccinated against in the 4 or 5 in one shots generally given spring and fall. The EHM mutation is not covered by this vaccine, but perhaps decreasing EHV-1 would decrease the incidence of it's mutation. The EHV can live outside the horse for 48 hours and is stable in high temperatures, so can be transmitted by humans, equipment and the environment, as well as horse to horse. Careful isolation and "biosecurity" must be enforced if a horse is suspected of having the disease. There is no cure and treatment is supportive. Antivirals are being studied.

The undersigned participant, and his or her parent or legal guardian if under the age of 18 years, does/do hereby execute this release waiver, and indemnification for himself/themselves and his or her/their heirs, successors, representatives and assigns and, thereby agree(s) and represents as follows:

To release Whips and Wheels Driving Club, it's members, agents and representatives affiliated with this activity from any liability, loss, damage, costs, claims and/or causes of action, including but not limited to all bodily injuries and property damage arising out of participation in the activity, it being specifically understood that said activity includes the handling of equine by the undersigned participant. The undersigned person(s) further agree(s) to indemnify Whips and Wheels Driving Club, it's members, agents and representatives affiliated with this project, and hold them harmless for any loss, damage, cost, claim judgment, or settlement which may be brought or entered against them as a result of the undersigned person's participation in said activity.

If involved in equine activities pursuant to NC Chapter 99E of NC General Statutes, the undersigned(s) executes(s) this waiver of the undersigned(s) right to sue and agree(s) to assume all risks resulting from the "intrinsic dangers of equine activities". "Intrinsic dangers of equine activities" is defined as those dangers or conditions that are an integral part of equine activities, including but not limited to: (i) the propensity of equines to behave in ways that may result in injury, harm, or death to persons on or around them; (ii) the unpredictability of an equine's reaction to such things as sounds, sudden movement, and unfamiliar objects, persons or other animals; (iii) certain hazards such as surface and subsurface conditions; (iv) collisions with other animals or objects; and (vi) the potential of a participant acting in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or not acting within the participant's ability.

This waiver shall remain valid unless expressly revoked by the participant or Parent or guardian of a minor. The revocation shall be in writing, which shall be addressed to the provider and shall become effective thirty (30) days after delivery to the provider. The undersigned(s) should maintain all medical and health insurance to cover all risks of any kind in any place in livestock, equine, and/or other activities.

I the undersigned participant will ensure equipment is in good condition at all times, wear and use all safety equipment. Minors (under the age of 18) MUST wear helmets and be accompanied by an experienced driver when in the carts/carriages.

<u>WARNING:</u> Under North Carolina law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities. Chapter 99E of the North Carolina general statutes.
